# NOTICE OF PRIVACY PRACTICES - EFFECTIVE: APRIL 14, 2003

Anderson, Linn, and Miami Counties in Kansas

This notice describes how medical information about you may be used and disclosed and how you can get access to this information. Please review it carefully.

# YOUR INDIVIDUAL RIGHTS

You have the right to:

- Request restrictions on how we use and share your health information.
  (We will consider all requests for restrictions carefully but are not required to agree to any restrictions.)
- Request that we use a specific telephone number or address to communicate with you.
- Inspect and copy your health information, including service and billing records. Fees may apply. Under limited circumstances, we may deny you access to a portion of your health information and you may request a review of the denial.\*
- Request corrections or additions to your health information.\*
- Request an accounting of certain disclosures of your health information made by us. The accounting does not include disclosures made for treatment, payment, and health care operations and some disclosures required by law. Your request must state the period of time desired for the accounting, which must be within the six years prior to your request and exclude dates prior to April 14, 2003.
  - (The first accounting is free but a fee will apply if more than one request in made in a 12-month period.\*)
- Request a paper copy of this notice even if you agree to receive it electronically.

Requests marked with a star (\*) must be made in writing. Contact the Tri-Ko, Inc. CDDO Privacy Office for the appropriate form for your request.

#### **OUR ORGANIZATION**

This notice describes the privacy practices of Tri-Ko, Inc. CDDO.

Tri-Ko Inc. CDDO includes clinics and other health care facilities owned by Tri-Ko, Inc. CDDO as well as the Tri-Ko Inc. CDDO employees and volunteers at those facilities. This notice also describes the privacy practices of affiliated providers while they are performing services in a Tri-Ko Inc. CDDO facility, unless they provide you with a notice of their specific privacy practices. Affiliated providers are not employed by Tri-Ko, Inc. CDDO but are either authorized to provide services to consumers in a Tri-Ko, Inc. CDDO facility or have a contractual relationship with Tri-Ko, Inc. CDDO.

Tri-Ko, Inc. CDDO affiliated providers may have different privacy practices from those described in this notice. For more information about the privacy practices of Tri-Ko, Inc. CDDO affiliated providers, please contact them directly.

## **OUR PRIVACY RESPONSIBILITIES**

# HOW WE USE YOUR HEALTH INFORMATION

We understand that health related information is personal. Protecting your information is important. We follow strict federal and state laws that require us to maintain confidentiality of your health information.

When you receive care from Tri-Ko, Inc. CDDO your health information may be used for serving or treating you, billing for services, and conducting normal business known as health care business operations. Examples of how we may use your information include:

#### **TREATMENT**

We keep records of the services provided to you. Health care providers may use these records to deliver quality care to meet your needs. For example, your physician may share your health information with a specialist who will assist in treatment. Some health records including confidential communication with a mental health professional and substance abuse records may have additional restrictions for use and disclosure under state and federal law.

## **PAYMENT**

We keep billing records that include payment information and documentation of services provided to you. Your information may be used to obtain payment from you, your insurance company, or other third parties.

We may also contact your insurance company to verify coverage for care or for notification of upcoming services that may need prior notice or approval. For example, we may disclose health information about services provided to you to claim and obtain payment from your insurance company or Medicare.

## **HEALTH CARE OPERATIONS**

We use health information to improve quality of care, train staff, provide customer service, manage costs, conduct required business duties and make plans to better serve our communities. For example, we may use your health information to evaluate the quality of services provided by staff.

# **SHARING YOUR HEALTH INFORMATION**

There are limited situations when we are permitted or required to disclose health information without your signed authorization. These situations are:

- For public health purposes such as reporting communicable diseases, work-related illness or other diseases and injuries permitted by law; reporting deaths, and reporting reactions to drugs.
- To protect victims of alleged abuse, neglect, or domestic violence
- For health oversight activities such as investigations, audits, and inspections
- For lawsuits and similar proceedings
- When required by law
- When requested by law enforcement as required by law or court order
- > To coroners, medical examiners, and funeral directors
- For organ and tissue donation
- > For research approved by our review process under strict federal guidelines
- To reduce or prevent a serious threat to public health and safety
- For workers' compensation claims or other similar programs if you are injured at work
- For specialized government functions such as intelligence and national security.

All other uses and disclosures, not described in this notice require your signed authorization. You may revoke your authorization at any time with a written statement.
